

6. The applications must be accompanied by attested photocopies of documents/testimonials, with regard to eligibility criteria as mentioned in Para 3.



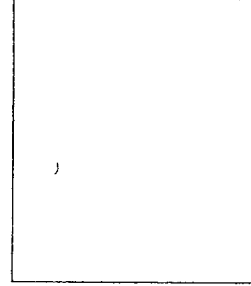
